D. GOOD NEWS IN OUR SCHOOLS

Churchill School

- With the support of Ms. Santalla, the fourth graders have been piloting the new school-wide Writing Fundamental Program. The program allows students to study areas of interest on various topics in order to complete research papers that have gone through all of the steps of the writing process. The program has fostered an interest in writing and has motivated even the most reluctant writer. The finished products have exhibited high quality work, pride, and dedication, which has been observed during the process by all parties.
- Fifth grade Science students are excitedly putting the final touches on their Escape Rooms for the big event on March 1, 2019.
- Sixth grade H.E.P. students have created robots and obstacle courses. Students needed to build a robot from parts that they had at home or from something they reverse engineered. Pupils then made their robot move through their obstacle course, while moving a ball, as well.
- L.E.A.D. (Law Enforcement Against Drugs) started in January and will continue through May. The sixth graders have enjoyed getting to know Officer Jim and Officer Jeff. Students are looking forward to the upcoming lessons.

Stevenson School

- Kindergarten had a very special delivery in January: twenty-four baby chicks were born! Farmer Tom dropped off the eggs and did a presentation about the chicks' parents, Max and Ruby. The students learned all about the life cycle of a chicken while actually watching it happen. What a wonderful way to learn through this hands-on experience.
- Students had a lot to celebrate in first grade. They voted to see if the groundhog saw his shadow. Their predictions were correct, but they don't know if they believe his prediction. Then, for Valentine's Day, students wrote about what love means to them. For the 100th day the class shared three clues to guess the 100 items inside the Mystery Bag. Also, students had publishing parties where they shared their "How Writers Work" writing pieces with the first grade classes. Students were very proud of their work and enjoyed presenting to their classmates.
- Second grade is having a wonderful start to 2019! Students celebrated Martin Luther King Junior through differentiated reading passages, articles, stories, and Scholastic News. They created a class book about their dreams for the world.

- This month, third graders have been busy learning many different things. Students have been working hard practicing their multiplication facts, learning to write about what they read, and creating a new animal species in Science. Students have been involved in many STEAM projects, including building with toothpicks and candies for the 100th day of school.
- Student Council was hit by cupid's arrow! Students sent their love to all Stevenson staff through Valentine's Day cards. Each member made a card for every staff member and delivered them on Valentine's Day with a smile. In addition, they challenged the families of Stevenson school to take part in the Great Kindness Family Challenge. Each family was asked to try to get "caught" being kind. They showed their kindness through an illustration or a photograph. Their "proof" is hanging in the halls for all to see. Staff was asked to show their kindness as well.
- Third grade H.E.P Students learned how to play Challenge 24. The object of the game is to make the number 24 from the four numbers shown.
