C. Good News

Stevenson School

- Kindergarten was busy in the month of December learning about many different holidays. A highlight was their Gingerbread Unit which included various gingerbread activities. The students decorated a family gingerbread at home and returned them to school for a bulletin board display. Gingerbread ornaments were made out of a special kindergarten mixture, which included glue and glitter. Each student also built and decorated their own gingerbread house at school with the help of their class mothers.
- First graders studied holidays throughout the year and were pleased to present their families with a personalized calendar as a holiday gift. The students will present their gingerbread stories at the January Board meeting.
- Second graders performed their holiday play titled, "Holiday Celebrations." They sang songs about different holiday traditions. Vita Scazafabo, Audriana Scalia, and Victoria Pereira were recently notified that they are the winners of a spooky story contest for a creative writing project done outside of school. Congratulations to the winners!
- Happy New Year! Third graders were on their first field trip of the year. Each child immersed themselves into the world of science at the Liberty Science Center! Students were able to test wind speeds of hurricanes at the Skyscraper, defy gravity in the Infinity Climber, enhance their sense of touch by crawling through the pitch black Touch Tunnel, draw with microbes, and work in a laboratory! At the end of the trip, students watched the 3D film titled "Oceans: Our Blue Planet," which taught the students all about the wonderful ocean life on their planet.
- The student council held a "guess how many" contest to benefit "The Wounded Warriors Foundation." Each guess cost \$1.00. Paul Winsor, a third grader, guessed exactly 176 peppermints in the jar. Mrs. Pero was the staff winner who guessed 160. They were awarded a \$15 gift card. The remaining \$275 was donated to the foundation. In addition to this event, each level of the "bird house" program met to make and build their own "winter" display on the school bulletin boards. Soon after, the boards were judged by secret staff members on their creativity, originality, and detail. The winning bulletin board was "Cocoa for Kindness" by the Blue Jays. This activity was a fun team building experience!
- HEP: First graders have begun coding! They are learning about debugging, which is an essential element of learning to program. This encounter, involving Blockly Based Coding, included working with puzzles that have been solved incorrectly. They needed to step through the existing code to identify errors, including incorrect loops, missing blocks, extra blocks, and blocks that were out of order.

Churchill School

• The fourth grade is enjoying a nonfiction unit in reading and writing. Learning about text structures and text features is always a blast. In writing, the students are working on informational writing tasks, including research writing. They are discovering the exciting world of space in the science and language arts units. Did you know that the earth is made of multiple different layers? They are also excited to continue their exploration of fractions in mathematics.

- The fifth graders are excited to construct and test out their Escape Rooms after weeks of planning and designing.
- Many students, within the sixth-grade class, participated in Buddy Day on January 8. They are happy to report that future West Essex band, chorus, and orchestra members practiced and performed songs with the current West Essex Middle School students! In addition, the sixth-grade students successfully kicked off their annual L.E.A.D. training on Monday, January 14. All sixth-graders will participate in this five-week program to gain a better understanding of how to become respectful members of the Fairfield community and to build a strong and long-lasting relationship with the Fairfield Police Department. Lastly, the West Essex Middle School Guidance Department visited Winston Churchill School on Tuesday, January 15, to discuss future class placement and to answer any questions.
- The enTREPreneurS Team (TREP\$), a program that teaches students how to create their own business, kicked-off an assembly on Thursday, January 16, for all students. The team is comprised of Mrs. DeSordi, Ms. Tirrell, Mrs. Malinowski and Ms. Kirk. The students were told about TREP\$ and encouraged to sign up. A large number of student participants are anticipated and the first workshop meeting will be held before school on February 13. This program will be funded with the assistance of the Municipal Alliance.
- All grade levels have been completing different projects based on the art element of "value." More specifically, the fourth graders have been combining this element with new lessons on one-point perspective to create a Salvador Dali inspired landscape. Fifth graders have been learning how to create value using paint. Sixth graders have been using the medium of pen-and-ink to create an abstract pinwheel of lines and shapes to show various tones of value. The Churchill artists look forward to displaying these pieces in the near future.
