## 2015-16 School Budget Highlights

1) Constraints are getting tighter . . .

2) State Aid still at 1/2 of 09-10 level (\$300K vs. \$600K)

3) Local Tax Levy Increase at 2.25% to help make up for continued loss of town ratables.

#### **2015-16 School Budget Highlights Items Deleted, Reduced, Reallocated or Not Needed**

- **1)** Business Administrator & Superintendent Rejected \$800K of Initial Budget Requests
- 2) Annual Flu Shots for Staff (AmeriHealth to conduct on-site clinic) (Save \$1,300)
- **3** Retirement of 1 Full-Time Teaching Staff Member (to be filled breakage of \$48K)
- 4) Lawn Service and Ball Field Anti-Weed Treatment (Save \$15,400)
- **3** Bus Routes (consolidate students into existing 15 routes) (Save \$112,000)
- 6) All 5 Administrators Voluntarily Waive National Convention (Save \$11,000)
- **7** Eliminated Budgeting for Sick Day Buyouts (Save \$32,000)
- 8) Continued On-Line Mandated Training Modules in Conjunction with Neighboring Districts to Save Time and Money (Save \$2,000)
- 9) CPR Training and Recertification (Save \$2,600) (Must re-cert. in 16-17)
- **Replaced Human Resources Software with alternative competitor (Save \$10,300)**

#### 2015-16 School Budget Highlights New/Increased Items

- **1)** New Kindergarten Teacher and Aide (5 Sections, over 100 new children) (\$75K)
- 2) New Full-Time Technology Assistant (\$55,000)
- **3) Part-Time Speech Teacher to Full-Time (\$39,000)**
- **4)** Increase Days for Safety & Security Coordinator (\$24,000)
- 5) Add 3 More Out-of-District Tuition Students & Transportation (\$174,000)
- Health Benefits Renewals anticipated to be close to \$200,000
- 7) One additional security camera at each school to further cover exterior
- 8) Continued Effort to "Go Green" with enhanced Website Interaction and to lessen copying of student "worksheets" and other paper producers
- **9)** Replace 2 unit ventilators at each school (\$45,000)
- **Reinforce Main Entrance at each school with enclosed "vestibules" (\$60,000)**

## Tax Base Analysis

 This loss contributed \$6 of the \$50 total tax increase.

Without the loss, the levy would have gone up only 2.0%, or \$44 on the average home.
